

Proceedings of the meeting on Jindal Steel & Power Ltd (JSPL), IPP for establishment of Hospital & Medical College, Power Training Institute and Higher Secondary School within a definite time period under the Chairmanship of Chief Secretary, Odisha on 27.04.2012 at 4.00 PM in the his conference hall.

The meeting was chaired by the Chief Secretary. The list of participants present in the meeting is annexed.

Initiating the discussion Commissioner-cum-Secretary, Energy informed that JSPL signed MOU with the State Govt. on 07.02.09 to set up 1320 MW IPP at Boinda in Angul district. Subsequently, JSPL formed a 100% owned subsidiary company namely Jindal Power Ltd.(JPL), transferred the independent Power business and applied to State Govt. to reassign MOU in favour of JPL. However, as the proposed location at Boinda is falling in command area of an irrigation project, project was relocated to Badkerjang as a patch of around 1100 Ac. of land originally acquired for JSPL for Steel project was lying in the name of IDCO due to the reduction in recommended land through benchmarking study by MN Dastur. Other major consideration was immediate availability of land to kick-start the power project.

13th HLCA held on 10.08.10 cleared for assigning the MoU in favour of JPL and 14th HLCA held on 04.05.11 cleared for relocation of site to Badkerejang with certain conditions and a draft Tripartite MoU has been prepared as per the advice of Law Dept. for signing amongst JSPL, JPL & GoO to this effect. Further as per the condition of HLCA, JSPL was supposed to develop a downstream Industrial Park before completion of IPP, establish Medical College and Hospital, Power Training Institute and Higher Secondary School. JSPL confirmed the willingness and committed to fulfill all the above conditions. IPICOL recommended 900 Ac. of land in favour of JPL for 1320MW IPP at Badkerjung, Angul.

The Executive Director of JSPL informed that JSPL signed MOU GoO to establish a downstream Industrial Park at Parang over approx. 1400 Ac. of land which was earlier notified under section 4(i) in favour of Essar Energy for establishment of IPP and was later vacated. IPICOL also recommended 1400 Ac. of land in favour of JSPL to IDCO for the Industrial Park at Parang which includes the land for Medical College & Hospital, Power Training Institute. JSPL received Administrative approval for the Industrial Park and 4(i) notification under process. Subsequently it was found out that a major part of the area (approximately 900 Ac) covering two villages (Parang & Mukundapur) falls under ayacut area.

It was further discussed that Energy Dept asked JSPL to give undertaking to establish Medical College & Hospital, Power Training Institute and Higher Secondary School within a definite time from the date of execution of supplemental MOU. JSPL already set up a modern HS School in township

area of Steel Plant, which is already functional. They confirmed to establish Power Training Institute within 2 yrs from commissioning of 1st unit of 660 MW and to establish Hospital within 2 yrs, Medical College within 3 yrs & HS School within 18 months of getting possession of land for the purpose.

A detailed deliberation was held amongst the participants and following decisions were taken.

- (i) JSPL will retain the non-ayacut portion of the land from their original application in village Parang and Mukundapur and leave out all the ayacut land of 900 Ac (approx.) from their original application of 1400 Ac. This revised land application amounting to 500 Ac (approx.) will form the 1st phase of their downstream Industrial Park and for establishment of Hospital & Medical College and Power Training Institute.
- (ii) Simultaneously, JSPL will have to survey and submit the land schedule, Map etc for the balance portion of the land from adjoining villages the feasibility of which would be ascertained from IDCO and District Administration. This would form the 2nd phase of Industrial Park.
- (iii) JSPL was asked to submit the revised land application for Phase-1 of downstream Industrial Park to IDCO immediately for expediting land acquisition process.
- (iv) The time line submitted by the company for various social and educational infrastructure projects like Hospital & Medical College, Power Training Institute and HS School will commence from the date of approval of 6(1) proposal of the proposed 500 Ac (approx.) of land for the 1st Phase of Industrial Park.
- (v) The above stipulations will be incorporated in the Supplemental MoU.

The meeting ended with participants thanking the chair.
