Dr. C.S. Kumar, IAS, Commissioner-cum- Secretary to Government Employment and Technical Education and Training Department chaired the meeting.

The agenda notes for discussion were placed before the Members. Items on the agenda along with some other points raised by the members with permission of the Chair were discussed. The minutes of the meeting are as follows.

The V.C., BPUT apprised the Committee that as per the decision taken in the earlier Scrutiny Committee held on 17.12.2012, he had constituted a Committee comprising of Dean of Engineering and Dean of Management to place their views on this issue. The Committee so constituted by the V.C., BPUT, Odisha, Rourkela is of the opinion that integrated and dual Degree courses in Engineering and Management may be started in the Constituent and Affiliated Colleges subject to inspection by the University for the said courses. As per the guidelines of the AICTE, in consultation with Deans of respective streams the OJEE shall take necessary action for conducting entrance examination for admission to above said courses. The V.C., BPUT submitted the report of the Committee (**Annexure-'A'**) and also gave his consent to the above recommendation of the Committee.

The provision of the AICTE for direct admission to 2nd year MCA programme and opening of a separate division for admission to 2nd Year MCA was discussed in the meeting. Further, the proposal of the Principal

Centre for IT Education for opening a separate division in MCA (2nd Year) for the BCA, B.Sc. (IT) and B.Sc. (CS) degree holders was discussed in the meeting.

After detailed deliberation on the above issues the Scrutiny Committee recommended as follows:

1. The Integrated and Dual Degree courses in Engineering and Management may be implemented in constituent and affiliated Colleges of the BPUT subject to following conditions.
 - (a) The BPUT shall conduct an Academic Audit / Inspection of the Institutions concerned who will submit proposal to implement the aforesaid courses.
 - (b) On receipt of the Academic Audit / Inspection report of such Institutions, the Government will consider on issue of NOC to the Institution.
 - (c) On receipt of the NOC of the Government, the University will grant provisional affiliation in favour of the Institution to run the said course.
2. The BPUT shall take steps to develop / prepare the course curriculum for the aforesaid programmes.
3. The OJEE Committee 2013 shall conduct entrance examination for the above mentioned Integrated and Dual Degree courses and for direct admission into 2nd year MCA programme.
4. The proposal for opening of separate division in MCA with 60 intakes for direct admission in 2nd year submitted by the principal CITE, Bhubaneswar may be recommended to the Government for approval.

The meeting ended with vote of thanks to the Chair.
