
Quotation / Tender Call Notice

No. OE II/29/2017(Pt) 2896 dated 13/6/19

Sealed Quotations/Tenders are invited from interested reputed Registered Travel Agencies/ Tour Operator or Private individuals for providing Diesel driven vehicle ((Innova A/C car) for official use of Hon'ble Minister, SD&TE Odisha on monthly rent basis at a maximum monthly rental of Rs 30,000/- per month.

- 1) The vehicle must be Road Worthy Condition, preferably less than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, Proof of up to date tax payment etc. which are mandatory for plying of vehicle.
- 2) The driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 3) The driver should be well behaved, gentle and obedient in nature.
- 4) A sum of Rs 5000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the SD&TE Department and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
- 5) The monthly rate of hire charge to be quoted separately in the general bid information (excluding fuel and lubricants).
- 6) The vehicle must achieve a fuel efficiency of 09 (Nine) km per litre.
- 7) The details of the make and year of manufacture of the vehicle, registration no, mileage (kms covered per litre) and name of the driver with driving Licence No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/ Tender.
- 8) The Quotation completed in all respect should reach the undersigned on or before **20 Jun 2019 by 2.00pm** and shall be opened on the same day 3.00pm in presence of the bidders or their authorised representative.
- 9) The authority reserves the right to cancel any tender without assigning any reason there to.
