Sub: Online portal for disposal of NOC applications and affiliation to all Polytechnics, Engineering & Professional colleges of the State.

Disposal of NOC applications and affiliation process of all Polytechnics, Engineering & Professional colleges under the administrative control of Skill Development & Technical Education Department of the State in a transparent and timely manner under 5T model of governance was under active consideration of Government. Keeping that in view a roadmap was prepared to make the system online with the help of OCAC, Odisha, Bhubaneswar.

Subsequently, in coordination with the stakeholders, i.e, BPUT, Rourkela; SCTE&VT, Bhubaneswar and OCAC, Bhubaneswar, a Portal named "Online NOC Management Portal" has been developed through which disposal of NOC applications for all Polytechnics, Engineering & Professional colleges shall be done in a time-bound manner from the date of issue of Notification.

Now, the Government have been pleased to approve disposal of such NOC applications in the said Portal with the following modalities :

- 1. The name of Portal shall be "Online NOC Management Portal".
- 2. All the NOC applications shall be received though online mode as per timeline approved by this Department.
- 3. In order to avoid vague applicants, a lump sum amount of Rs.5,000/- to be collected from the applicant for each type of NOC through iFMS integration. However, for this Academic Session, no collection of fees shall be done.
- 4. Affiliation process shall also be included in this Portal in due course.
- 5. Keeping in view of the last date of application of AICTE Portal, for this Session, the Portal shall be made LIVE on 20.01.2024 with the tentative timeline as follows :
 - a. Application submission period : 20th- 25th Jan, 2024.
 - b. Inspection period : 26th- 29th Jan, 2024.
 - c. Disposal of NOC (either by Department or Affiliating Board) : 31st Jan, 2024.
- 6. Subsequent decisions, i.e., extension of timeline, making the Portal user-friendly, inspection details, disposal of NOC, etc. shall be decided by the Department from time to time and accordingly, be intimated to all concerned.
