

2. The appointees shall be placed on probation for a period of two (2) years from the date of their joining in the service.
3. Their appointments are purely temporary subject to verification of character and antecedents and may be terminated at any time without prior notice and without assigning any reason thereof.
4. No Traveling Allowance and Dearness Allowance shall be admissible for joining their place of postings.

At their time of joining, the appointees are instructed to furnish the following documents/undertakings to the Principal of the concerned institution:


1. Certificates in support of Educational Qualification (Original and Photocopy)
2. 2 (two) Nos. of Character Certificates issued by 2 (two) Nos. of different Gazetted Officers (Original)
3. A declaration to the effect that no criminal antecedent/case is pending against him/her (original).
4. Declaration of non-contact of plural marriage (original)
5. Caste Certificate (if candidate belongs to ST/SC/SEBC) (Original and Photocopy)
6. Disability Certificate, if applicable (Original and Photocopy)
7. Sports Certificate, if applicable (Identity card of Sports persons issued by the Director of Sports, Odisha) (Original and Photocopy)
8. Medical Fitness Certificate from a Medical Officer not below the rank of Chief District Medical Officer (CDMO) to the effect that he/she is free from all communicable diseases and is fit to render Government Service.
9. 2 (two) Nos. of passport size photographs
10. Relief certificate from present employer, if he/she is already in service elsewhere.






